Undergraduate Transfer Scholarship Program

- Annually awards approximately **60 scholarships** worth **up to \$30,000** per year to students and recent alumni from accredited two-year colleges and community colleges.
- Each campus may nominate between two and four applicants depending on institutional enrollment.
- **Basic eligibility:** Nominees must have at least a 3.50 GPA; have sophomore status by December 31, 2010, or have graduated in the past five years from an accredited two-year institution; and plan to enroll full-time in a bachelor's degree program beginning in fall 2011. The Foundation's selection criteria include academic excellence and significant financial need.
- Deadline: **Internal campus deadlines vary.** Application deadline is **January 19, 2011.** Nomination deadline is **January 26, 2011.**

Hispanic Scholarship Fund

Community College Transfer Scholarship Program

- Annually awards over **400 scholarships of \$1,250 and \$2,500** to students attending or transferring from a two-year college to a four-year institution.
- Students applying may be planning on attending a community college or transferring to any U.S. accredited four-year institution in the U.S., Puerto Rico, the U.S. Virgin Islands, and Guam in fall of 2011 or spring of 2012.
- **Basic eligibility:** Applicants must be of Hispanic heritage; be a U.S. citizen or legal permanent resident; be currently enrolled part-time or full-time at a community college; have plans to enroll **full-time** at a community college or transfer to a four-year, U.S.-accredited institution **full-time** during the 2011-2012 academic year; have a minimum cumulative GPA of 3.00.
- Deadline: Apply online at www.hsf.net by **December 15, 2010.**
