Our college intends to use, no less than 50 percent of the funds received under S ection 18004(a)(1) of the CARE Act to provide Emergency Financial Aid Grants to students.

Aultman College has received subsequent awards through the Higher Education Emergency Relief Fund II (HEERF II) authorized by the Coronavirus Response and Relief upplemental Appropriations Act, 2021 (CRR AA).

Total Amount of Funds Received

Aultman College has received \$147,862.00 from the Department pursuant to our Certification and Agreement for Emergency Financial Aid Grants to students.

Aultman College received a subsequent award through HEERF II in the amount of \$147,862.00 for a grand total of \$295,724.00 in Emergency Financial Aid Grants to students.

Aultman College has received \$147,862.00 from the Department pursuant to our Certification and Agreement for the Institutional portion.

Aultman College received a subsequent award through HEERF II in the amount of \$415,999 for a grand total of \$563,861.00 in the Institutional portion.

Aultman College has received \$189,698.00 from the Department pursuant to our Certification and Agreement for the FIP E portion. S 7/1/2021 3 CAR A Reporting

A ltma College has received \$14,578.00 from the Department pursuant to our Certification and Agreement for the SIP portion.

Total Amount of Emergency Financial Aid Grants Distributed

Aultman College has distributed a total amount of \$297,250 in the form of Emergency Financial Aid grants to students under Section 18004(a)(1) of the CARES Act as of April 8, 2021.

Estimated Total Number of Students Eligible to Participate

The college estimates a total of 300 Aultman College students are eligible to participate in 3 programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid grants to students under Section 18004(a)(1) of the CARES Act.

Method(s) Used to Determine Which Students Receive Emergency Financial Aid Grants

Aultman College will follow Department of Education rules to distribute HEERF grants directly to students. These grants reimburse students for expenses related to disruption of campus operations due to COVID-19. Funds go directly to students and are not used by the 4 college to offset outstanding student balances. Maximum grant amounts are determined by the 4 college based on available funds.

The following eligibility criteria govern HEERF grant distributions. Students must:

- be Title IV eligible as indicated on current FAFSA application;
- be enrolled on or after March 13, 2020, the date the state of emergency was declared; and 4
- complete the application and expense attestation forms.

Note: Students enrolled in an exclusively online program are not eligible to receive these grants. 4
